Chelsea Irwin serves the Lord through The Lutheran Church—Missouri Synod (LCMS) in the Eurasia region as missionary coordinator for volunteer opportunities. Based out of Český Těšín, Czech Republic, she works with LCMS missionaries and local church partners to place and send volunteers to serve in Eurasia. These individuals or groups engage in projects such as English Bible Camps, theo-

logical education and mission education, to name a few. Chelsea seeks to challenge volunteers to live out the Great Commission by viewing each day as a mission trip. She encourages them to support and stay connected to the Eurasia region, as well as serving in their own churches and communities.

Chelsea's home congregation is Holy Savior Lutheran Church, Lincoln, Neb. She earned a bachelor's degree in early childhood education, with a minor in English as a Second Language (ESL), from Concordia University, Nebraska, Seward, Neb. Chelsea worked as an assistant teacher at Touching Hearts Early Childhood Center at Faith Lutheran Church in Lincoln, Neb., for six years. From 2010–2019, she served as a volunteer at Jawornik English Camp in Jawornik, Poland, where she taught English, Bible stories and music to middle school students. She also served as an LCMS missionary in Bohumín, Czech Republic, for a year and a half (2020–2021). Chelsea's hobbies include spending time with friends, hammocking, traveling, making music and trying new foods.
