Call To Order

The meeting was called to order by Rev. Briel at 9:00 am. All members (Rev. Peter Bender, Rev. Steve Briel, Mrs. Carol Hack Broome, Ms. Carla Claussen, Rev. Tim Droegemueller, Rev. Approval of Minutes

The October 2021 minutes were presented. It was moved and adopted to approve the minutes as presented.

Chief Mission Officer Report, Rev. Kevin Robson

See attached report. Highlights:

Rev. Robson shared the wonderful work being done both within the Offices of National and International Mission, but also within Pastoral Education where there is a central push from basically everyone in the International Center around the Church Worker Recruitment Initiative, *Set Apart to Serve*. The *Life Together as Synod* videos continue to be produced and disseminated in order to educate the church about Synod and her role.

Mission Advancement reports extremely successful relationships with donors and other institutes. There is an enormous sign of trust in the fact that individual and congregational contributors are donating to the unrestricted fund in order to allow Synod to use those dollars as she sees fit.

LCMS Communications continues the search for a new Executive Director and hope to have someone in place by the end of this fiscal year.

Office of National Mission Unit Executive Report, Rev. Bob Zagore

See written report. Highlights:

Rev. Zagore shared the strong work being done by the Office of National Mission across the country. For instance, the Mental Health task force is moving forward to provide resources to speak as the church in the larger cultural conversation. The Spanish language hymnal is produced and preparing for shipment. Lutheran Early Response Teams (LERT) continue to serve in the Pacific Southwest and responded to the disasters in Kentucky beautifully.

A total of 963 Soldiers of the Cross grants totaling \$1.635M were given to church workers caught in difficult situations since the COVID-19 pandemic began.

He expressed that the four year cycle between conventions was refreshing. He shared the work being done at the seminaries for recruitment which is being done alongside the longer term Set Apart to Serve initiative. Synod is calm.

Governance Policy Subcommittee Updates/Discussion

The Foundation is undergoing strategic movement after a comprehensive report given from an external operating auditing company. Mrs. Hack Broome expressed her pleasure at how the Foundation is responding to the report and the determinations they will be considering at their next meeting.
