### Report on Nominations for President, First Vice-President, and Other Vice-Presidents

Bylaws 3.12.1–3.12.1.6 establish our Synod’s process for receiving nominations and determining five candidates each for the offices of President and First Vice-President and 20 candidates for the offices of Vice-Presidents two through five. During October 2009, each voting congregation of the Synod received its official nominating ballots and the opportunity to nominate ordained ministers to each office. The official deadline for the return of these nominating ballots was March 10, 2010.

The Office of the Secretary, with the approval of the Board of Directors of the Synod, engaged the auditing firm of Brown Smith Wallace to tabulate the nominations. As required by Bylaw 3.12.1 (d), the following is a full report of the results of the nominating process.

### **Amendments to the Slates of Candidates**

Bylaw 3.12.1.3 provides opportunity for the convention to alter the slates for President, First Vice-President, and other Vice-Presidents by amendment. A motion, second, and majority vote is necessary. Prior written consent of such candidates is required and, along with pertinent biographical information, must be submitted immediately to the Secretary of the Synod by the delegate making the nomination. Forms for this purpose are available upon request from the Office of the Secretary. After all such amendments have been received and voted on, the convention ratifies the slate of candidates prior to each election.







## BIOGRAPHICAL SYNOPSES AND STATEMENTS OF NOMINEES

### NOMINATIONS 2010 SYNODICAL CONVENTION

The Committee for Convention Nominations (CCN) met December 3–6, 2009, and January 11–13, 2010. A subsequent conference call meeting on March 11, 2010, was necessary to respond to changes and corrections to the initial nominations list that were brought to the committee’s attention after the list was publicized. Those changes were made without dissenting vote.

As the CCN went about its work in preparation for the 2010 convention, it struggled because of an unusually low number of nominations submitted from the Synod at large. Due to a lack of eligible nominees for some positions, the committee was not always able to provide the number of candidates necessary to fulfill the requirements of Bylaw 3.12.3.6 (a). The committee prayerfully presents its best effort as it presents the candidates listed in this publication.

Elections will occur during the July 10–17, 2010 convention in Houston, Texas. The committee expresses its appreciation to all who allowed their names to be considered for nomination.

#### SECRETARY

##### 1 ordained minister to be elected

**Qualifications:** The Secretary must be an ordained minister with the skills necessary to perform the customary duties of a corporate secretary; carry out the required responsibilities relating to conventions of the Synod; perform such other work as pertains to his office by bylaw or by assignment by conventions, the President, or the Board of Directors; and provide counsel from the Constitution, Bylaws, and resolutions of the Synod to the members of the Synod on a daily basis. Administrative responsibilities include oversight of the Synod’s dispute resolution process and supervision of the official rosters of the Synod. Membership on numerous boards, commissions, and committees includes service as secretary of the Commission on Constitutional Matters and of the Board of Directors. A high degree of integrity is essential, and a range of prior experience in the Synod will be helpful.
