Motion: Made by Mrs. Claussen and seconded to approve the minutes of the February 2016 meeting.  
Motion carried.

Chief Mission Officer Report – Rev. Kevin Robson

- May 18 observed one year as CMO
- Adopted balanced budget of approximately \$95 million; ONM increased by about 7% to \$10 million, decreasing spending from unrestricted funds
- Floor committee meetings produced a fine set of resolutions for the July Synod Convention
- Communications continues to work with Mission Advancement
  - Budget allows \$1 million to seek funding for mercy ministries
  - *Lutherans Engage ...* will add mobile platforms in the next year

Synod President Report – President Matthew Harrison

- Reviewed the Matt Becker case
  - Floor committee proposing the return of an appeal process to the Praesidium of Synod by the accuser
- Floor committees meeting was “fantastic”; multiple committees spread the work around
- Floor committee members selected from those with the highest rankings provided by District Presidents
- In discussion with the Malagasy Lutheran Church of Madagascar
- Question: are there any discussions with other synods? Response: no discussion with the ELCA; we are talking with Rome, starting with the Sacrifice of the Mass; talks with WELS, ELS, NALC
- First Amendment rights being challenged in the military chaplaincy
- Question: Is there any discussion regarding allowing the Cup to be used in prison ministry? Response by Rev. Mueller: Federal system allows the Cup; state systems vary

Executive Director’s Report – Rev. Bart Day

- Shared video prepared for the Synod Convention
- Highlights of ONM
  - Worker Wellness working group examining data from past decade to determine best practices and/or gaps

- Pornography Summit unleashing the Barna Study prepared over the past few years; John Kleinig contracted to write a theology of the human body; working with Doxology and Grace Place to pilot therapy
- Connecting with LCEF, LCMS Foundation, CPS to highlight resources available to workers
  - LCEF and LCMS Foundation will provide funds to ONM for domestic grants
- Ongoing opportunities to interact with the ELCA via LIRS and LSA
  - Sponsorship of refugee families by congregations
- Scouting
  - Overtures to convention were placed in the omnibus resolution and assigned to the BNM/ONM
  - Various Christian organizations for both boys and girls need to be addressed by the task force
- 2016-2017 Budget
  - Of the \$10 million, \$4 million is related to salaries and benefits, of which \$0.5 million is for contracted work; \$3 million for grants and partnerships; only \$0.5 million from unrestricted funds; requested full time worker in church planting that was not fulfilled
- Witness Coordination
  - Four of the six directors in witness work are deployed staff; need for intentional internal coordination with additional time in the building
- Youth Ministry
  - Strategic planning for the coming 3-10 years prior to any staffing additions/changes
- ONM as a department
  - Staff meeting/retreating in August
    - Convention resolutions
    - Reporting mechanisms
    - Ambassadors of Reconciliation training for conflict situations in which they find themselves
- Respite retreat with Grace Place for employees of ONM/OIM
- District connections
  - Original pilot with eight districts
  - New district presidents have provided additional opportunities
    - Kansas, English, Missouri
- Life and Health Ministry
  - Stephanie Neugebauer will be leaving due to husband accepting call to Northern Illinois
  - There is Discussion/Evaluation regarding separating Life Ministry and Health Ministry among OIM/ONM/CMO prior to any staffing
- Schools
  - Discussion with Alliance Defending Freedom regarding litigation pertaining to schools and the federal government
  - *Protecting Your Ministry* document to be provided to all congregations and schools
- Seminary Connections
  - EEIT
  - Draft of a Memorandum to create a Rural and Small Town Ministry Institute at CTSFW
- Youth Gathering
  - 1600+ congregations, about 200 more than previous
  - Roughly same number of participants

## Ministry Presentation—Church Planting – Rev. Steve Schave

### Mission Field: USA

- ONM investing in working with districts to assist in their church planting efforts
  - Mother congregations
  - Sponsoring circuits
  - Planting networks
- Flexible framework for technical support, training, and equipping
- What's been done?
  - Roundtable
  - Center for US Missions support
  - Seminary Mission Formation
  - Vicarages/Internships
  - National missionaries—recruit/assess/orient/train/fund—often in challenging areas
    - New church planters manual
    - Grants (seed money)/Funding (LCEF \$2 million for revolving loans)
    - Conferences
  - Survey in coordination with US Center for Missions to identify generic patterns
  - Use Luther's seven marks of the church
    - Witness
    - Baptism
    - Holy Communion
    - Office of the Keys
    - Consecration/Calling Ministers
    - Prayer, Public Praise, and Thanksgiving
    - Possession of the Sacred Cross
  - Outward Sign—Christian life of Loving our Neighbor

- Revitalization Cycle—initiated by the congregation
  - Initiate
  - Access resources
  - Self-assessment
    - 360 survey
    - Lay Leaders' Questionnaire
    - Pastor's Questionnaire
    - Statistics and Metrics
  - Chart a Course
  - Workshop with leadership of the church
  - Develop action plan
  - Execute action plan
  - Evaluate action plan/results
- Action-Oriented Training
  - Ten modules
    - Connect to Disciple first module (14 congregations)
- Vocational Evangelism
  - Paired with LCMS Evangelism Program (*Every One His Witness*)
- Facilitators
  - Districts identify and recommend "trainers" who train the district facilitators
- Coaches
  - Currently negotiating contract for development of training materials

50-75 congregations currently in some stage of re:Vitality

Ministry Presentation—Lutheran Young Adult Corps – Julianna Shults

The Board heard a report from Ms. Shults regarding the Lutheran Young Adult Corps

- Development began in 2012 at request of President Harrison
- Full-time – either 10 months or 10 weeks beginning June 2017
- Communities in need, particularly under-served urban
- Gap year – ages 18-26
- \$1000 to participate; refundable upon enrollment in CUS

- Up front funding from World Relief and Human Care donations for mercy work
- Required living together in community with training in Bible and Lutheran theology
- lcms.org\yacorps

#### Synod Convention BNM Related Issues

14-03 To Respond Compassionately to Challenges to Biblical View of Marriage and Human Sexuality

Final resolved: That the LCMS in convention direct the ~~Board for National Mission~~, Office of National Mission, Concordia Publishing House, ....

18-02 To Task the Board for National Mission to Assess Worker Wellness to Make Recommendations for Worker Care

Line 26: that the Board for National Mission ~~take up the responsibility for~~ prepare policies for the Office of National Mission to address

Motion carried.

#### Foundation Report – Ernie Garbe

Mr. Garbe provided the following information to the Board: the Foundation

- Now managing 180 estate plans for the St. Louis Seminary
- Will make presentations and exhibit at the Milwaukee Convention and NYG
- Examined a Mutual Fund offering and subsequently declined to do so

The Foundation works cooperatively with ONM in the area of grant distribution.

Net assets improved by \$215,000 during the quarter; net assets were down for the year by \$674,000 due to investment valuation.

Rev. Robson is now also a member of the LCMS Foundation Board.
